What personal information do we collect from the people that visit our blog, website or app??

When ordering or registering on our site, whichever appropriate, users may be asked to enter their name, email address, mailing address, phone number, credit card information or other details to help with their online experience

When do we collect information?

We collect information from users during site registration, order placement, newsletter subscription, survey response, and any online form completion.

How do we use customer information?

We use the information we collect from users, for their convenience when making a purchase, signing up for our newsletter, responding to a survey or marketing communication, from our website, or using certain other site features in the following ways:

To improve our website in order to better serve our customers.

To allow us to better service our customers in responding to customer service requests.

To administer a contest, promotion, survey or other site feature.

To quickly process transactions.

To send periodic emails regarding customer orders or other products and services.

How do we protect visitor information?

Our website is scanned on a regular basis for security holes and known vulnerabilities to make customer visits to our site as safe as possible using regular Malware Scanning. Personal information is contained behind secured networks and is only accessible by a limited number of persons who have special access rights to such systems, and are required to keep the information confidential. In addition, all sensitive/credit information that users supply is encrypted via Secure Socket Layer (SSL) technology.

We implement a variety of security measures when a user places an order enters, submits, or accesses their information to maintain the safety of personal information.

All transactions are processed through a gateway provider and are not stored or processed on our servers.

Do we use 'cookies'?

Yes. Cookies are small les that a site or its service provider transfers to a computer's hard drive through the Web browser (if allowed) that enables the site's or service provider's systems to recognize the browser and retain certain captured information.

For instance, we use cookies to help us remember and process the items in a user's shopping cart. They are also used to help us understand user preferences based on previous or current site activity, which enables us to provide users with improved services. We also use cookies to help us compile collect data about site track and site interaction so that we can better site experiences and tools in the future.

Users can choose to have computer notifications each time a cookie is being sent, or turn o all cookies through the internet browser's settings. Each browser is a little different, so look at the browser's "Help" menu to learn the correct way to modify cookies.

If users disable cookies in their browser:

If cookies are disabled, some features will be disabled turning o some of the features that make our customers' site experience more efficient and some of our services will not function properly.

However, customers can still place orders over the telephone by contacting customer service

We do not sell, trade, or otherwise transfer personally identifiable information (PII) to outside parties unless we provide the user with advance notice. This does not include website hosting partners and other parties who assist us in operating our website, conducting our business, or servicing our customers, so long as those parties agree to keep this information confidential. We may also release user information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others' rights, property, or safety.

How does our site handle do not track signals?

We honor do not track signals and do not track, plant cookies, or use advertising when a Do Not Track (DNT) browser mechanism is in place.

Does our site allow third party behavioral tracking?

COPPA (Children Online Privacy Protection Act)

When it comes to the collection of personal information from children under 13, the Children's Online Privacy Protection Act (COPPA) puts parents in control. Fair Information Practices

Within 7 Business Days we will notify the users via e-mail, phone call, letter, and site notification.

We also agree to the individual redress principle, which requires that individuals have a right to pursue legally enforceable rights against data collectors and processors who fail to adhere to the law. This principle requires not only those individuals have enforceable rights against data users, but also that

individuals have recourse to courts or a government agency to investigate and/or prosecute non-compliance by data processors.

CAN SPAM Act

The CAN-SPAM Act is a law that sets the rules for commercial email, establishes requirements for commercial messages, gives recipients the right to have emails stopped from being sent to them, and spells out tough penalties for violations.

We collect our customer's email address in order to:

Send information, respond to inquiries, and/or other requests or questions.

Process orders and to send information and updates pertaining to orders

We may also send additional information related to a user's product and/or service

Market to our mailing list or continue to send emails to our clients after the original transaction has occurred

To be in accordance with CANSPAM we agree to the following:

NOT use false, or misleading subjects or email addresses

Identify the message as an advertisement in some reasonable way

Include the physical address of our business or site headquarters

Monitor third party email marketing services for compliance, if one is used

Honor opt-out/unsubscribe requests quickly

Allow users to unsubscribe by using the link at the bottom of each email

If at any time our customers would like to unsubscribe from receiving future emails, they may simply follow the instructions at the bottom of their most recent e-mail so we may promptly remove them from ALL correspondence.
